Road Opening Licence - Conditions of Application Form B

1.0 FEE:

1.1 A fee of €250.00 shall be payable by the Applicant in respect of each road opening.

2.0 Reinstatement Fee/ Bond:

- 2.1 The Contractor shall pay a Reinstatement fee or bond to Kilkenny Council. The reinstatement fee shall be repaid to the contractor twenty four months after satisfactory completion of all road reinstatement works. The reinstatement fee is calculated by Kilkenny County Council.
- 2.2 A longTerm Impact Charge (non- refundable) shall apply, which is calculated at 20% of the reinstatement costs.

3.0 Insurances:

- 3.1 The Applicant shall provide Kilkenny County Council with evidence of adequate Public liability Insurance, which shall extend to all aspects of the works including the opening and restoration of trenches in Public Roads, and shall include a General Indemnity with a minimum limit of €6,348,690 for any individual claim. Kilkenny County Council must approve the insurance before work can commence.
- 3.2 Public Liability Insurance cover shall be extended to indemnify Kilkenny County Council against Third Party Claims, with a minimum limit of €6,348,690 for any individual claim.
- 3.3 The Applicant shall be responsible for the satisfactory performance of reinstatement until a Date of Completion has been formally agreed between the Applicant and Kilkenny County Council and confirmed in writing. The Insurance referred to in 3.1 shall remain in operation until the said date of completion.
- 3.4 The Applicant shall provide Kilkenny County Council with a complete and accurate set of drawings showing "as constructed" layouts of duct lines not more than six months after the works have been completed.

4.0 Reinstatement Specification:

4.2 Where ducts are to be laid in paved surfaces, the following procedures shall apply:

Drawing SD14 Grass Verges, Medians, Fields and Lawns

- (a) The limits of the **area** required for excavation shall be marked on the road surface and agreed with Kilkenny County Council.
- (b) The paved surface shall be cut through with a road-saw so that a clean straight edge is provided to the limit of the area required for excavation.
- (c) Excavation shall be confined to the area prepared.
- (d) If the paved surface should be damaged beyond the prepared area, the limits of the damaged surface shall be marked, cut as specified above and removed. The new exposed area shall be restored as specified above.
- 4.3 All Road Markings, warning signs, direction signs and other signs (e.g. non-statutary signs erected with the approval of Kilkenny County Council) disturbed by the works shall be restored to as-new condition by the Applicant, and to the satisfaction of Kilkenny County Council.
- 4.4 All surface water outlets, roadside drainage channels, road gullies, surface water drainage pipe work, culverts and bridges disturbed by the works shall be restored to full working condition by the applicant. In particular road culverts, box-shores and bridges shall be restored/maintained in a manner approved by, and to the satisfaction of Kilkenny County Council.
- 4.5 All roadside amenity areas (e.g. paved or grassed areas, lawns special features, planting, etc) disturbed by the works shall be restored to their original condition by the Applicant to the satisfaction of Kilkenny County Council.
- 4.5 Ducting through bridge structures shall not be permitted. It is the responsibility of the Applicant to liaise with TheOffice of Public Works.

5.0 Method Statement

5.1 Upon awarding the Road Opening Licence, the applicant must submit for approval by the Area Engineer, a Method Statement outlining how works are to be completed, including:

- Number of Operatives
- Number & type of Mechanical Plant on site
- How existing services are to be identified and protected.
- Details on Traffic Control Plans
- Name & 24 hour contact number of competent person working on site
- Details on trench is to be protected during works
- If the trench is located within a footpath, how pedestrians are to be cateredfor.
- Source of Bituminous Material (Wearing course macadam PSV > 60
- Location for disposal of excavated spoil (use of off road dumpers on public road is strictly prohibited)

6.0 Traffic Control

- 6.1 Traffic control measures are the sole responsibility of the Applicant and shall be in accordance with Chapter 8 of the Department of Environment Traffic Signs Manual. Such measures shall remain in operation until the works are fully completed to the satisfaction of Kilkenny County Council.
- 6.2 Additional measures may be required at the direction of Kilkenny County Council including the provision of additional signage or temporary traffic lights, which may be deemed necessary to control and warn traffic and pedestrians at specific locations.
- 6.3 All warnings signs shall conform to Chapter 8 of the Traffic Signs Manual and shall be kept clean and visible at all times.
- 6.4 It is the responsibility of the Applicant to notify the Gardai and emergency services of any traffic control measures.
- 6.5 The start and finish times of works shall be decided by Kilkenny County Council.

7.0 Health & Safety

7.1 It is the sole responsibility of the Applicant to comply with Health & Safety legislation.

8.0 General

- All works shall minimise disruption to traffic, the public, property owners and residents. Applicants shall liaise with local businesses to ensure minimum disruption.
- 8.2 All material used in conjunction with the works shall not be stored on the public road, footpath or verges.
- 8.3 Kilkenny County Council reserve the right to withdraw the licence in emergency situations or where there is a breach of the licence conditions.

9.0 Supervision

Before or during works, Kilkenny County Council may decide that on -site supervision is required. An additional condition may be added which sets out an hourly rate for such supervision and the Applicant must pay the same within fourteen days.
