#### (b) <u>Roads – Bóithre</u>

#### (i) Amenity Grants

Mr. John Mulholland presented a report on the allocation of amenity grants. He advised that a budget of  $\leq 35,000$  has been provided in the 2013 budget. 75 applications were received requesting grants to the value of  $\leq 111,700$ . He referred to his report which outlined the types of works that are appropriate for consideration under the grant scheme.

It is recommended to the Council to approve the distribution of the €35,000 as detailed in the schedule circulated. It was proposed by Cllr. Billy Ireland, Seconded by Cllr. M. Shortall and

resolved; "That Kilkenny County Council approves the payment of Amenity Grant 2013 in accordance with the list circulated to members".

- (ii) Proposed Cllr. Jane Moran Seconded by Cllr. M O' Brien and resolved:- "We the members of Kilkenny County Council approve the initiation of proceedings for the taking in charge of Maudlin Court, Thomastown, Co. Kilkenny (Planning Reg. Ref. P00/1410 & P03/1700) in accordance with Section 180 of the Planning & Development Act 2000".
- (iii) Agreement between Kildare County Council and Kilkenny County Council in accordance with the provisions of Section 85 of the Local Government Act, 2001 for the Leinster Bridges Rehabilitation Contract No. 1 2013 Part 1.

Mr. Mulholland referred to report circulated with the agenda which outlined details of section 85 Agreement required to enable Kildare County Council to carry out rehabilitation works on bridges in Kilkenny in the interest of efficiency and value for money. Details of works are outlined in the report and most likely these works will be undertaken in 2014. It was proposed by Cllr. M. O' Brien, Seconded by Cllr. J. Brennan and resolved: - "At the monthly meeting dated 20<sup>th</sup> May, 2013 Kilkenny County Council hereby resolves, in accordance with the provisions of Section 85 Local Government Act, 2001, to enable Kildare County Council to design, plan, procure and deliver the Leinster Bridges Rehabilitation Contract No.1 – 2013 as it relates to County Kilkenny (rehabilitation works on N78 Clashduff Bridge)

#### (iv) Draft Noise Action Plan

Mr. Mulholland advised members of an EU Requirement to make a noise action plan for the period 2014-2018 in relation to motorways and national

roads where there are more than 3 million vehicle passages per year. The proposed plan contains strategic noise plans, estimated population exposed to traffic, implementation of more detailed assessment to the relevant affected areas and identification of actionable works to mitigate against excessive noise – all subject to cost benefit analysis.

Public consultation on the draft plan commenced on  $3^{rd}$  May, 2013 and will extend to  $21^{st}$  June, 2013, further reports will issue to members after this.

#### (v) Community Involvement Roadwork's Scheme Status Report

Mr. Mulholland advised members that a copy of circular letter RW7/2013 received today has been circulated to them advising that a grant of €346,064 has been allocated to Kilkenny County Council for Community Involvement Scheme for works on several local roads.

Mr. S. Walton, Senior Engineer gave a PowerPoint presentation to members on the status of the Community Involvement Scheme. He outlined in his presentation the background to the CIR in County Kilkenny.

There have been 303 schemes completed in Kilkenny involving 150km of road since 1995. The total investment was €8.4m, i.e. Restoration Grant of €6.5m and local contributions of €1.6m. There is now a waiting list of 69 applications. There is a well established community network for CIR Schemes on the local territory network and there has been significant support to date from the elected members for the 7.5% Restoration Grant discretion. Most of the local territory roads are beyond the provisions of routine/localised maintenance.

Mr. Walton referred to the reply dated 26<sup>th</sup> April, 2013 received from the Department of Transport and Sport in relation to the flexibility of individual local authorities to reserve 7.5% of the Restoration Grants to CIR Schemes. Copy has been circulated to members.

Contributions were received from Cllrs. M. Doran, M. Shortall, J. Brennan, T. Breathnach, P. Dunphy and T. Maher.

Members welcomed the grant allocation for 2013, however are disappointed that the flexibility of 7.5% on the Restoration Programme grant for Community Involvement Scheme has not been restored. It was agreed to request the Department again to re-instate this flexibility.

Clarification was sought on whether new applications could be accepted by the Council for future years and in relation to those who had not responded that these applications remain on the list. Mr. Walton replied to all queries raised.

It was agreed to write to the Department outlining the member's request.

#### (c) Finance - Airgeadais

#### **Draft Capital Budget**

Mr. J. Crockett advised that the Council is legally required to approve a capital budget for a three year period. He stated that each Director of Service will present the draft budget for each of their departments. Report and detailed schedule of proposed projects for each service area has been circulated.

Mr. J. Dempsey advised that that total capital spend is approx €67m over the 3 year period. €11m of the spend will have to be funded by the Council. Development Charges constitute the largest element of the local funding approximately €7.0m of development charges will have to be available for spending on capital projects over the period 2013-2015 i.e. €3.1m from unspent contributions and €4.5m from projected development charges. A relatively small contingency reserve of €0.6m is retained for the end of 2015 to act as a "buffer" against any unforeseen events. The ability to deliver the projects depends on all funding resources becoming available. Any project proposal not included within the approved budget can only proceed if alternative funding sources become available and/or already approved projects been dropped.

Mr. McCormack gave details of a proposed capital budget of  $\in$ 5.7m for housing services. The expenditure will be funded by way of government grants of  $\in$ 4.1m. ICR  $\in$ 1.1 and other funding  $\in$ 0.5m.

Mr. Mulholland outlined the proposed road projects. Total expenditure of €39.6m, of which €14.7m will be incurred during the period 2013-2015. Details on each project was given and the source of funding. Total government grants of €29.7m will be required, development charges €7.5m and other funding €2.4m.

Mr. P. O' Neill presented details on the Water Services Capital Budget of €80.8m.
He advised that 6 schemes are underway for 2013. Funding for projects in 2013 will require development contributions of €1.6m and government grants of €3.1m. It will be the responsibility of Irish Water to fund Capital Projects from 1<sup>st</sup> January, 2014.

Mr. Mulholland advised that expenditure on Graiguenamanagh Fire Station will be post 2014. He outlined details on the Library Projects and Ossory Pedestrian Bridge.

Mr. Dempsey outlined details on the replacement track for Scanlon Park. Mr. J. McCormack gave details on the recreation and amenity grant scheme which is 100% funded from Development Charges.

Mr. Crockett advised that provision is being made for the purchase of the Diageo site and proposed development for the 1<sup>st</sup> time in the Capital budget. These are indicative figures at this stage.

Contributions were received from Cllrs. P. Dunphy, J. Brennan, M. Noonan, M. Doran, C. Long, M. Shortall, M. Brett, F. Doherty, S. Treacy, T. Breathnach, M. O' Brien, J. Coonan, P. Cuddihy, D. Fitzgerald, M. H. Cavanagh and T. Prendergast.

Members in general welcomed the draft budget. Clarification was sought by individual members on the various projects included in the draft budget for the period 2013-2015. Details as follows:-

#### Housing:

- Projects under the social housing investment programme

- No provision for remedial work on rural cottages
- Clarification on Council's land bank

#### Roads:-

- Status of Mooncoin By-Pass
- Central Access Scheme and Northern Ring Road -Extension to proceed together- traffic at Kennyswell Street, Demolition in Vicar Street
- Greensbridge Bridge, necessity to provide additional river crossing in the city.
- Smarter travel proposals

Water Services:-

- Unaccounted for water leaks
- Mains Replacement
- Need to advance all projects before transfer to Irish Water
- Clarification on individual schemes

Clarification was also requested on the status of the City Library Project, improvements at the Watershed/Scanlon Park.

The Directors of Service responded to all queries raised. Mr. Crockett thanked the members for their contributions and their consideration on the draft capital budget for 2013-2015. The completion of the projects will depend on the availability of the relevant grants and the collection of development levies.

It was proposed by Cllr. M. O' Brien, seconded by Cllr. B Ireland and agreed "That the Draft Capital Budget 2013-2015 as presented to members be adopted".

Mr. Crockett advised the meeting that this was Mr. Dempsey final council meeting. He paid tribute to John and wished him success with his career with Irish Water.

Cllr. M.H. Cavanagh, M. O' Brien, M. Doran and M. Noonan thanked Mr. Dempsey for all his excellent service with the Council and in particular his contribution at all the Council Meetings especially his clear presentations on the budget each year.

Members wished him well with his career with Irish Water. Mr. Dempsey thanked the members for their comments and well wishes. He also thanked the County Manager and work colleagues.

Mr. Mulholland advised that the draft annual report has been circulated for member's information. The Council is required to adopt the report by the end of June 2013. Cllr. Cuddihy requested more information to be included in relation to Kilkenny Borough Council. The adoption of the draft annual report for 2012 was proposed by Cllr. T. Maher, seconded by Cllr. M. O' Brien and agreed.
