**Item 1**                    **Minutes of SPC 5 Meeting held on 13<sup>th</sup> April, 2017**  
Proposed by Cllr Shortall, seconded by James Murphy and agreed:- "that the minutes of SPC5 held on 13<sup>th</sup> April, 2017, a copy of which was circulated to each member with the Agenda, is hereby adopted"

**Item 2**                    **Animal Welfare Charter**  
Mary Mulholland opened the meeting by stating that an animal welfare charter needs to be developed and adopted and that any animal welfare committee could buy into it. Discussions took place and contributions were made by James Murphy and Cllr. Joe Malone

**Item 3**                    **Draft River Basin Management Plan Submission**  
Mary Mulholland advised that a substantial submission had been made and advised that a further meeting on the implementation plan would be held in October by Carol McCarthy, Senior Engineer and Ann Phelan, LAWCO.

Discussions took place and contributions were made by Cllr. Maurice Shortall, Cllr. Pat Dunphy, Cllr. Tomas Breathnach and Shem Caulfield

It was agreed that there is a need to develop a cohesive approach.

**Item 4**                    **Litter Management Plan**  
Bernadette Moloney gave a presentation on the Litter Management Plan. The current plan runs out in December 2017. It is hoped to bring the new Plan to the full Council by January 2018. Bernadette requested that comments be sent into her in writing within two weeks.

A discussion took place on various forms of preventative measures such as cameras, black spots, tidy towns, name and shame and prosecution.

It was agreed that there is a need for the Council to highlight the good work that is currently being done.
